### Which Side to Root For

Over the past 15 years, I have watched a lot of high school football. This is one of the benefits of being friends with a football coach’s wife. Most of those years have been cheering for the De Pere football team. However, as a Bay Port alum and having my nephew Austin played for Bay Port, there were a few years when my allegiances changed. Now Austin is in college and I’m back to rooting for De Pere.



Honestly, I haven’t been able to completely turn my back on either team, despite which side I’m sitting on. I have ties to both sides of the football field. How could I go from cheering for the Pirates one year to cheering for the Redbirds the next, without any regard for the other team? I am unable to totally switch loyalty for one team at the expense of players and coaches I know personally on the other side.

So what does this have to do with our faith and, more specifically, this weekend’s Gospel?

Jesus was tested by the Pharisees and Herodians (two opposing sides) to see where his allegiance lied. His response of “repay to Caesar what belongs to Caesar and to God what belongs to God,” teaches us we don’t always have to position ourselves firmly with one side at the expense of the other. Jesus recognizes we have earthly and spiritual responsibilities, and we cannot forgo one for the other.

We must find balance between actively participating in the world and our commitment to God. We owe everything to God and must always prioritize the teachings of Jesus while living within society. The sacred is found within the secular. God wants us to be authentic in our earthly and spiritual duties without being hypocritical.

Life is not black and white. We should not strive to live as “either/or” but more of a “both/and” kind of life. One aspect of life should not diminish at the cost of the other. We can all support the good, whether it is on the football field or in life.

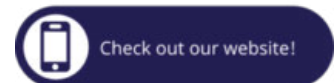
