Lord, in Your Great Love, Answer Me

The words of today's Psalm speak to the heart: "Lord, in your great love, answer me." We all experience moments when we feel misunderstood, burdened, or alone. Maybe you have days like me, where you are asking the Holy Spirit to show you signs that encourage because you feel your prayers are not being answered. Like the psalmist, we may find ourselves carrying responsibilities that seem heavy or making sacrifices that go unnoticed. Yet the Psalm reminds us that God sees every act of faithfulness and hears every prayer offered from a sincere heart. God's kindness is abundant, God's mercy is constant, and God's love never fails.

This message is especially meaningful as we celebrate Father's Day. Today we give thanks for the fathers, grandfathers, godfathers, stepfathers, and father figures who have answered God's call to love, guide, protect, and provide for others. Their vocation often requires quiet sacrifice, perseverance, and a willingness to put the needs of others before their own. Like the psalmist, many fathers carry burdens that are not always visible. Yet they continue to serve with devotion and generosity. We thank them for reflecting the faithful love of our Heavenly Father.

The Psalm we will hear after the first reading this weekend invites all of us to place our trust in God. "You who seek God, may your hearts revive!" Whether we are celebrating joys or carrying concerns, the Lord hears us. God does not abandon people. As we gather in worship this weekend, may we lift our hearts in gratitude for the fathers who have blessed our lives and renew our confidence that God answers us in God's great love. 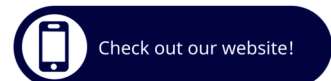

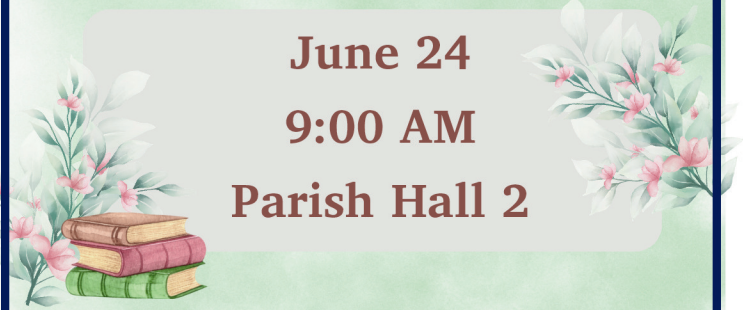
